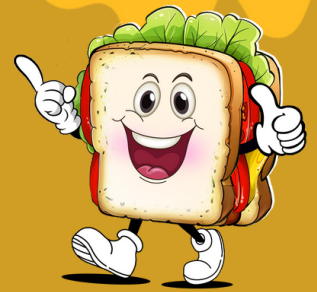


# PRIVACY POLICY



## Effective Date:
